## Corporate Archive Presentations –

Steve Granger, Archdiocese Archives, gave us a slide and tape show of the history and growth of the archives Archdiocese archives. There was some discussion of research fees (the Archdiocese charges \$15.00/hour for doing research and \$15.00/day if someone comes in to do research). Most requests are for genealogy or parish histories.

Katie Dishman, General Mills, talked about the history of the archives and passed around a book that was put together for the 75<sup>th</sup> anniversary (*General Mills 75 Years of Innovation*).

Bruce Bruemmer, Cargill, led us on a tour of the Cargill archives at the end of the meeting, describing how it had changed and expanded since he started in 2000, and showed us some of the displays around the main building. He also presented a list of what makes corporate archives different from other archives.

#### **Award Winner**

TCART member Dr. Julian G. Plante won this year's Kay Sexton Award at the 16th Annual Minnesota Book Awards ceremony on April 25, 2004. The Kay Sexton Award is presented to an individual who has made outstanding contributions to the community of the book in Minnesota.

Plante, who was introduced by former Minnesota Governor Elmer L. Andersen, was singled out for his scholarship and service as founding director of the Hill Monastic Manuscript Library at Saint John's Abbey and University in Collegeville, the work on the Minnesota book world he is conducting in a volunteer capacity at the Minnesota Historical Society, his service to the Friends of the Ramsey County Suburban Libraries, the Ramsey County Historical Society, etc. He was featured in an article by Sarah T. Williams, "Bookmarks: Writing the book on books," in the Star Tribune, Sunday, May 16, 2004, p.F14.

# Conservation Workshop

The Upper Midwest Conservation Association (UMCA) will hold a two-day workshop, "Care and Preservation of Books and Archival Materials: Storage Enclosures" August 19-20 at the James J. Hill Library in St. Paul. Neil Cockerline, UMCA Director of Field Services and Conservator, will present the hands-on workshop, which will cover book and paper preservation with an emphasis on proper storage techniques and materials.

Agents of deterioration, mold and mildew prevention, pests, environmental controls and disaster recovery will be reviewed and discussed. Participants will learn how to make various acid-free enclosures for paper artifacts, books, and photographs including matting and framing options, polyester encapsulation and encapsulation corners, four flap folders, custom made book boxes, and techniques for rolled storage of oversized paper artifacts.

The workshop is designed for individuals who work with library, archives, and fine art collections. Participants are invited to bring a sample object with storage issues to discuss during a clinic. (Arrangements must be made beforehand. Objects with mold, mildew or pest damage will not be allowed.) The workshop fee is \$245 or \$195 with UMCA member discount.



## SAA Statement on the **Nomination of Allen** Weinstein to Become Archivist of the United States

April 14, 2004

We are concerned about the sudden announcement on April 8, 2004, that the White House has nominated Allen Weinstein to become the next Archivist of the United States. Prior to the announcement, there was no consultation with professional organizations of archivists or historians. This is the first time since the National Archives and Records Administration was established as an independent agency that the process of nominating an Archivist of the United States has not been open for public discussion and input. We believe that Professor Weinstein must—through appropriate and public discussions and hearingsdemonstrate his ability to meet the criteria that will qualify him to serve as Archivist of the United States.

When former President Ronald Reagan signed the National Archives and Records Administration Act of 1984 (Public Law 98-497), he said that, "the materials that the Archives safeguards are precious and irreplaceable national treasures and the agency that looks after the historical records of the Federal Government should be accorded a status that is commensurate with its important responsibilities." Earlier in 1984, when the National Archives Act was being discussed,

Senate Report 98-373 cautioned that if the Archivist was appointed "arbitrarily, or motivated by political considerations, the historical records could be impoverished [or] even distorted."

P. L. 98-497 clearly states that, "The Archivist shall be appointed without regard to political affiliations and solely on the basis of the professional qualifications required to perform the duties and responsibilities of the office of Archivist." In 1984, House Report 98-707 noted, "The committee expects that [determining professional qualifications] will be achieved through consultation with recognized organizations of archivists and historians." The law also states that when the Archivist is replaced, the President "shall communicate the reasons for such removal to each House of Congress." President Bush has not given a reason for the change, and there is no evidence to suggest that it is being made because of John Carlin's resignation.

We agree with these statements and believe that the decision to appoint a new Archivist should be considered in accordance with both the letter and the spirit of the 1984 law.

We call on the Senate Committee on Governmental Affairs to schedule open hearings on this nomination in order to explore more fully 1) the reasons why the Archivist is being replaced and 2) Professor Weinstein's qualifications to become Archivist of the United States. Among other issues, we believe it is important to learn more about Professor Weinstein's:

 Knowledge and understanding of the critical issues confronting NARA and the archival profession generally, especially the challenges of information technology, and the competing demands of public access to government records, privacy, homeland security, and ensuring the authenticity and integrity of all records.
